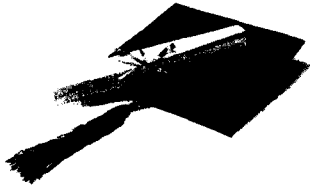

Re: How to apply for the Oswego Teachers Employees Federal Credit Union
Scholarship

1. Complete the front page applicant section. Make sure you've completed the essay.
2. If you are a high school senior:
 - Have a parent or legal guardian sign the application.
 - Have a teacher complete the reference section.
 - Ask your Guidance Department for an official copy of your transcript and SAT or ACT scores. If your transcript does not include a straight(not weighted) grade point average as of the end of 11th grade, ask the Guidance Department to add this piece of information to the transcript.
3. Submit all of the information to the **Oswego Teachers' E. Federal Credit Union** no later than the close of business on **Friday, April 30, 2010.**

The Award

The Oswego Teachers' Credit Union scholarship is (14) fourteen \$250 and one (1) \$500 award to be paid directly to the member in the form of a check to them and the educational institution.

Eligibility

The applicant must be a member in good standing of the Oswego Teachers' Employees Federal Credit Union. The member must be a college-bound high school senior at the time of application. Scholarship funds must be used: (1) for tuition, (2) only at a two- or four-year accredited educational institution.

Application Process

- ___ 1. *The application must be submitted together with:*
___ *An official high school transcript*
___ *An SAT/PSAT/ACT transcript*
(obtained through the high school guidance office)
___ *Teacher's letter of reference*
- ___ 2. *The applicant and his/her parent or guardian must sign the Certification and Release Authorization on the back page of this form.*
- ___ 3. *The application, transcript and essay must be returned by **Friday, April 30, 2010.** If any portion is incomplete or not included, the application will not be considered.*

Selection Process

Judging will be based on both subjective criteria and weighted, objective criteria. These include academic performance, the essay, community activities and personal goals.

Application Deadline

*Application must be returned to the Credit Union no later than **Friday, April 30, 2010.***
