- 2. Submit all of the information to the Oswego Teachers' E. Federal Credit Union no later than the close of business on Tuesday, April 30, 2024.

### The Award

The Oswego Teachers' Credit Union scholarship is (7) seven \$500.00 and one (1) \$1,000 award to be paid directly to the member in the form of a check.

The applicant must be a member in good standing of the Oswego Teachers' Employees Federal Credit Union. The member must be a college-bound high school senior at the time of application. Scholarship funds must be used for tuition and room/board. The scholarship is for only at accredited educational institutions, including trade schools.

(obtained through the high school guidance office)
Teacher's letter of reference
 _ 2. The applicant and his/her parent or guardian must sign the Certification and
Release Authorization on the back page of this form.

3. The application, transcript and essay must be returned by the deadline. If any portion is incomplete or not included, the application may not be considered.

#### **Selection Process**

Judging will be based on both subjective criteria and weighted, objective criteria. These include academic performance, the essay, community activities and personal goals.
